#### Chair's Corner

The central committee hopes to see many of you tomorrow evening at our special event from 5:00 to 7:00 p.m. in the lobby of the Francis Scott Key Hotel on the corner of Patrick and Court Streets. The event is designed to send a strong message that we will resist the politics of polarization and hate and continue our mission to keep Democratic principles and values alive in Frederick County.

The event has over 65 sponsors who have given from \$75 to \$6000 to jump start our fundraising efforts. We thank them all for their most generous contributions and for their commitment to Democratic Party success. There is no charge for tomorrow's event, but contributions are most welcome.

All proceeds will go toward electing Democrats in Frederick County in the very important races coming up in 2018 as well as the city elections in 2017. The money is going into our so-called "lockbox." In 2014, the central committee was able to provide professional polling and consulting services to Jan Gardner and our county council candidates, our legislative team, and other county and state candidates for the first time ever. to the tune of about \$55,000. We are hoping to double that amount by the beginning of 2018, and we are about halfway toward that goal.

We also hope to focus on the down-ballot races and those offices (such as the legislative district 4 positions) that historically have gone to Republicans. We are seeing unprecedented activist energy across the county since the Trump election. People are angry and fearful, and they want change for the better. Change begins right here; it begins with harnessing some of that activist

energy and applying it toward fielding candidates with progressive and positive values. In 2018, we will have over forty positions to vote on; they range from U.S. senator and governor to central committee members and judge of the orphan's court. With the funds we are now raising, the central committee should be in a position to assist candidates running in the down-ballot races with data access, training and support.

To help prepare activists to run for office, the central committee will also be conducting two full day workshops – one in May, the second in November. For potential candidates under the age of 35, one very helpful website is

www.runforsomething.net. It is our hope that the anger and frustration many now feel can be positively redirected toward making Frederick County a better place. We all seek change; let's start by making some changes right here at home.

As we begin to formulate our strategy for the upcoming elections, we want to hear from you. We want to know your concerns, your ideas for changing conditions for the better, your suggestions for what the central committee has not done and/or should be doing. I think we all agree that change is needed and that some serious rebuilding and reassessing is needed in the Democratic Party. We value your input and your ideas. Over the next few weeks, we plan to meet with a number of our stakeholders to get their thoughts. On Thursday, April 20, we will be holding a town hall meeting in the Community Room at the C. Burr Artz Library, which will be open to everyone. We will have more details in the coming weeks. Please join us for what we hope will be a lively discussion that will lead to some concrete proposals for moving forward. Come with your ideas, your criticisms, your aspirations.

For some time now, the central committee has been grappling with the name of our annual fundraising event – the Jefferson Jackson Dinner. This year, it was a major item on the agenda of our annual retreat that was held last weekend. Not unlike central committees across the country, we have been torn between evaluating the contributions of both men within the context of the time in which they lived and embracing a more contemporary identify for today's party. At issue is whether Presidents Jefferson and Jackson represent the values of the modern Democratic Party inclusiveness, equality and diversity. While recognized as major historical figures and party founders, both were men of controversy and contradiction. They were both slave owners, and Jackson cannot escape condemnation for his policy

against Native Americans. At the same time, changing the name could erase the reminder of where the Democratic Party first began. After considerable debate, we agreed to simplify the name. Beginning with the June 2017 event, our major annual fundraiser will be called the Frederick County Democratic Gala. Only the name will change; everything else you have come to expect from our annual dinner will remain the same, and we look forward to seeing you there.

# SENATOR RONALD YOUNG

With the first half of the 2017 session already complete, I wanted to bring you up to date with some of the more recent legislative efforts in Annapolis. With less than 45 days to go, we have already passed some legislation and will continue to focus on passing bills to help all Marylanders.

On February 16, the Maryland Senate passed Senate Joint Resolution 5, the Maryland Defense Act. This bill passed the House and became law as Joint Resolution 1 (JR1), giving the attorney general the authority to protect Maryland against the disastrous acts and policies of the current presidential administration. Unlike 41 other states, the Maryland Constitution does not give our attorney general the authority to act without permission from the general assembly or governor. JR1 provides the Maryland attorney general the ability to act the way our citizens expect.

The senate also voted to override a veto of the Renewable Portfolio Standards Bill. This bill focused on clean, renewable energy that creates jobs, cuts down on longterm power bills, and makes sure that Maryland does its part in the fight against climate change. In addition, the bill established that Maryland receives 25% of its electricity from renewable energy sources like wind, solar, and other renewable energy fields. I voted to override the veto and keep Maryland on track with renewable energy, growing and keeping new energy jobs in Maryland, and improving the air quality and health of all residents.

On February 13, the senate passed my bill (SB268) to place a moratorium on cownose ray fishing tournaments. You may have seen one of the videos on this brutal practice which have gone internationally with upwards of three million hits. Working together, the senate was able to create a compromise to stop this practice, giving Governor Hogan an opportunity to study the cownose and better regulate their protections. I am proud of the bipartisan work the senate did to protect these Chesapeake Bay natives.

In addition to Cownose Ray bill, my bill to not tax new unleaded forms of aviation gas (SB54) also passed the senate on February 20. Several other bills I introduced are moving through the committee process to be sent to the senate floor for vote. I will report on them further as they pass the senate.

Three of my bills have been heard, and two have moved forward to a subcommittee for a more extensive hearing. What follows is a complete list of my legislative initiatives for this session and the scheduled hearing dates:

HB is the House Bill number, and SB refers to the Senate cross-file. HB158 is a bond bill for the Frederick County Historical Society, which will probably be heard on 3/11.

# "The Rest of the Story - "Doc"

Last month, I wrote about former commissioner and delegate Wally Hutton, whose political career ended in 1974. Hutton died on December 6, 2016, at age 87. James "Doc" McClellan also served in local government (as Frederick City alderman) and the Maryland General Assembly; however, his political career lasted for twenty years, and longer if you count his service on the Liquor Board after retiring from the Maryland House of Delegates. Unlike Wally, Doc was very much a part of the Frederick establishment. Both he and his father were well-respected veterinarians for large and small animals. McClellan was born in Frederick, whereas Wally came to Frederick from Montgomery County. McClellan died on November 26, 2016, at age 90.

My first memory of Doc was during his 1973 campaign for alderman. My Young Democratic Club colleague, Ron Young, had been elected to the Board of Aldermen in 1969 (our fellow Young Democratic Club member, Galen Clagett, got through the primary for alderman but finished 121 votes behind Republican Glenmore Rice for the 5<sup>th</sup> slot on the Board of Alderman in 1969). In 1973, Young beat Glenmore Rice for mayor; and Doc, in his

first run for political office, finished first in the alderman race. Ron, a dynamic young, progressive mayor, and Doc, representative of the Frederick establishment and fourteen years Ron's senior. formed a lifetime political relationship during the 1973-1977 Frederick City administration. Ron was re-elected mayor in 1977 and continued to serve until 1990. Doc decided not to stay in local government but to move on to the state legislature and was elected to the House of Delegates in 1978. leading the ticket. He continued to serve four more terms until he retired in 1994. After retiring from the House of Delegates, McClellan was appointed to the Frederick County Liquor Board and served there until 2012. He also served on the Frederick Fair Board for 65 years. Doc and his wife, Betty, hosted the first Frederick County Plowman and Fisherman event at their house on Rockwell Terrace, with special guest Comptroller Louis Goldstein.

McClellan was a powerful and popular member of the House of Delegates, particularly as he teamed with Frederick Senator Charles Smelser to make sure that Frederick County received its share of the state budget, particularly capital projects. Doc was instrumental in gaining support from the Maryland General Assembly for state funded projects for Frederick City while Ron was mayor.

While Ron had a positive relationship with Doc, the relationship between Galen and me and Doc was not particularly good. I think that Doc perceived me, eighteen years his junior, as a troublemaking young challenger to his establishment proclivities. Truth be told, I respected him as a legislator, and he probably had

Frederick's most progressive record as a member of the Maryland General Assembly during his time, with the possible exception of Charlie Smith.
