The Chair's Corner-

On behalf of the Frederick County Democratic Central Committee, I recently wrote an open letter to Governor Hogan, urging him to heed the requests of the Maryland Association of Elections Officials, the League of Women Voters, Attorney General Brian Frosh, and many others to implement mail-in voting for the November 3 election.

Ordering the in-person polling places to remain open for both early voting and election day is impractical and dangerous, as Senator Young points out elsewhere in this edition of the Banner. I would like to reinforce his points here. Jurisdictions are already announcing that they will have to consolidate locations because their boards of election can't get enough poll workers to staff them all. School buildings, where many precincts go to vote across the state, will be closed – as well they should be. As Maryland's COVID cases are on the rise, voting in person presents a public health risk that we cannot take

In addition, what happens when some voters refuse to wear a mask to the polls? We have seen enough violence from "anti-maskers" at retail stores to know that we can probably expect belligerent unmasked voters to likewise behave badly: to cough on poll workers, spit on paperwork, and otherwise endanger their neighbors. Why invite trouble?

Voting by mail is obviously safer, and it's also less expensive than what the governor is proposing. By automatically mailing all voters the application for a ballot, instead of the ballots themselves, he potentially doubles the cost to the taxpayers. The Maryland Association of Elections Officials says that where this system has been tried, it was found to be "costly, inefficient and unsuccessful."

Two more quick items: Sadly, we couldn't have a gala this year, but look for news about our virtual rally and fundraiser, to be scheduled for sometime in October. As I write this, the details are being hammered out, but hopefully our events committee has made the important decisions in time to get a save-the-date into this issue of the Banner. If not, watch our Facebook page in the coming days – and I'm sure we'll have full event information for you next month.

Senator Ron Young- District 3

Last month, Governor Hogan indicated that Maryland would hold an in-person presidential election this November, despite safety concerns over the ongoing COVID-19 pandemic.

I support sending each registered voter a mail-in ballot (formerly called “absentee” ballot) for the general election. We need to ensure that everyone has the option to cast their ballot safely.

One cause for concern with the election is the possibility that we will not have enough election judges or polling locations. Many people who tend to serve as election judges are seniors and fall into the high-risk category. Many may opt, out of concern for their safety, not to work the polls this November.

It is a shame that Governor Hogan has dug his heels in and is playing President Trump’s game to suppress the vote. We need everyone to be mailed a ballot. We could have a hybrid system with about a third to a half of the polls open in each county. We could find enough poll workers to open this many polls. There is still time to adapt the system if the governor would put the health and convenience of our citizens above politics.

In Maryland, voters do have the option of requesting a mail-in ballot without having to provide a reason explaining why they cannot vote in person. I encourage voters to request a ballot for several reasons. First, this is the safest way to vote as it allows you to maintain social distancing and reduces the risk of potential exposure to the virus. Second, if more voters opt for a mail-in ballot, this will help reduce lines and wait times at polling locations for those who do vote in person.

NOTE FROM THE CENTRAL COMMITTEE: Delegate Lewis Young submitted this piece for the July Banner. We apologize for our oversight in not including it last month.

Work at the state legislature is focusing on three topics: unemployment claims, police reform, and coronavirus planning.

Since the stay-at-home process began, there have been an abundance of unemployment claims that were not processed in a timely manner. Our office has followed up on approximately 90 claims that were backlogged with the Department of Labor. At this point, about 94% of those claims have been resolved.

On June 16, House Speaker Adrienne A. Jones, along with all 98 Democratic delegates, sent a letter to Governor Hogan asking him to issue an executive order for all state policing agencies to take affirmative steps in police reform.

“This is not a partisan issue: I don’t care who gets the credit. We need to start implementing policing changes now,” said Speaker Jones. “With the stroke

of the pen, Governor Hogan has the power to save someone’s life today.”

The legislators specifically asked the governor to immediately:

- Ban the use of chokeholds;
- Require that deadly force is used only to “stop an imminent threat of death or seriously bodily injury to the officer or a citizen”;
- Require a duty to intervene for those police officers who see another officer using unnecessary force;
- Implement an early warning system to identify incidents involving use of force and immediately re-train that officer;
- Ban shooting at vehicles,
- Require that every officer within a state law enforcement agency sign an affirmative written sanctity of life pledge.

This request reflects existing best practice recommendations by the Maryland Police Training and Standards Commission but are not required among policing agencies in Maryland. Governor Hogan directly oversees ten policing agencies plus higher education policing agencies within the University System of Maryland.

I believe that this is a good start, but much more work needs to be done with screening police candidates, ongoing psychological testing, and sensitivity training. Also, funds that have been allocated to purchase military style weapons and training should be reallocated to community investments in health care, education, and social programs.

Speaker Jones announced the creation of the House Police Reform and Accountability Workgroup in early June, which will look at comprehensive statutory changes to improve

transparency and implement new requirements to prevent police misconduct. Judiciary’s vice chair, Vanessa Atterbeary, will lead the House Workgroup.

Maryland’s mental illness challenges are being exacerbated by the COVID-19 pandemic. Modeling is predicting 200,000 suicide deaths coming this year nationally, 75,000 of those cases being attributable to COVID-19 related mental health trauma. Many health care experts are predicting that the second wave will be accompanied by mental illness challenges that are equal to, if not greater than, COVID-19 itself

I have been appointed to serve on the Governor’s Commission to Study Mental and Behavioral Health. The commission is tasked with studying mental health in Maryland, including mental illness challenges associated with the COVID-19 pandemic. As part of my role on the commission, I will also serve on the Crisis Services Subcommittee.

These assignments align with my dedication to better address Maryland’s mental illness challenges.

Delegate Ken Kerr-

District 3B

This is normally the time when we would be thinking about next session and what we hope to accomplish. However, with the current COVID crisis, it's difficult to plan. Honestly, we don't know what the 2021 legislative session will look like.

Last session was an ambitious one, where I introduced twelve pieces of legislation involving access to higher education, agriculture, consumer protection, family medical leave, school safety, medical practice, and the craft beverage industry. It was an aggressive legislative agenda, much of which was undone by the 90-day session being shortened by 19 days. One of my bills, HB0880: Maryland Healthy Working Families Act - Family Member – Definition, passed both houses and was signed by the governor. This clarification FMLA allows the spouse of a legal guardian to provide care for a legal dependent.

HB0882 Financial Institutions - Abandoned Property - passed both chambers but an amendment added by the senate slowed the bills return to the floor for concurrence and did not make it back to the House in time before we adjourned *sine die*. It turns out that banks do not have

fiduciary responsibility to act in the account holder's best interest and need only attempt to notify the account holder one time, by first class mail before turning the assets over to the state. HB0882 directs the financial institution to contact by certified mail return receipt if the assets are \$1000 or more. With the shortened session, we were unable to reconcile the difference before *sine die*. I will prefile this bill after working with all constituencies to agree upon a number that works for everyone.

I will also re-introduce HB0428 Health Occupations - Podiatric Physicians, which modernized the professional terminology for podiatrists and HB0675 Education – Public Schools – Seizure Action Plans (Brynleigh's Act). About 1.5 million people in America have epilepsy, and 25 percent of new cases of epilepsy occur in children 14 years and younger. This makes it highly likely that a child's first unprovoked seizure will take place at school, and population-based estimates suggest that every year 25,000 to 40,000 children in the United States experience a first unprovoked seizure. Seizures are frightening for everyone having or witnessing one. There was some opposition as to when and where this 45-minute training should take place that needs to be worked out. If we can get that worked out before January, I'll prefile this bill as well with Senator Young as the cross-file once again.

The bills with which I have had the most success are those brought to me by you, my constituents. You are the people most affected by outdated or unfair laws and regulations. Your perspective and your stories are what helps to get unfair and outdated laws fixed and new laws put in place to help families, businesses, the environment and our children's future. So please contact me if I can be of assistance to you.

Stay safe; stay well; wear a mask. We will all get through this if we work together.

The Rest of the Story

August 17-20 will be the dates for this year's Democratic National Convention. It will be a convention like no others – almost entirely virtual. No delegates, alternates, standing committee members or guests will actually be in Milwaukee, the site of this year's convention. Hopefully, it will be a television spectacular. For those who had planned to attend, either as guests or delegates, it will be a disappointment. Attending a Democratic National Convention is a "political junkie's" heaven. All voting by delegates will occur between August 3 and August 17 and will be via e-mail. The results will not be announced until the week of the convention.

Historically, at least going back to the 1972 convention, Frederick County has a tradition of sending delegates, alternates, and committee members to Democratic National Conventions. Information as to who has been a delegate, alternate or standing committee member is hard to come by. The information I am providing in this column is by memory (with Bob Kresslein's help), which is always suspect, and so if I have left anyone out, I apologize. In addition to quadrennial Democratic National

What is virtual activism? Simply, it's taking actions from anywhere via computer, phone, or other device to get out the vote for Democrats. And with many of us doing this in Frederick County and combining with others throughout Maryland, and everywhere in the country, we become a powerful grassroots force for Democratic victories up and down ballots in November.
