Last month, members of the General Assembly received a copy of a Letter of Advice from the Office of Counsel to the General Assembly from the Office of the Attorney General answering questions from the Chiefs of Staff of Senate President Bill Ferguson and House Speaker Adrienne Jones regarding legal questions on holding a legislative session during a pandemic or other emergency.

The Maryland State Constitution requires that the General Assembly meet in Annapolis. Questions for consideration include whether or not legislators can hold committee hearings remotely, and whether or not they must be physically present in the Senate and House chambers in the State Capitol to vote on legislation.

Based on the letter from the Office of Counsel to the Attorney General, it suggests that legislators could hold their committee hearings remotely so long as the public has access to witness those hearings.

However, in terms of voting to approve pieces of legislation, which is done in the Senate and House chambers in the Capitol,

any passed legislation or veto overrides could and likely would be challenged in court on constitutional grounds if votes are held remotely instead of having legislators physically present in the same location in Annapolis. There are also several areas for consideration regarding how votes would be cast and how to authenticate that votes are actually being cast by the legislators. For legislators to vote, they must be marked as “present” in the Senate or House chamber. The letter of advice noted that legislators, when they enter the chamber, are marked as being present, but there is not necessarily an official record of them leaving if they do not stay for the entirety of the floor session.

A few weeks ago, I made a suggestion to Senate President Ferguson that the House and the Senate could isolate themselves by committee, and with television screens, hold floor debates and vote on legislation, while physically being in Annapolis but without requiring all legislators to be in the Senate or House chambers. This could meet the constitutional obligation to meet in Annapolis and reduce the risk of COVID-19 infection throughout the entire House or Senate and their staff.

With nearly 200 hundred legislators and hundreds of staffers working at the State Capitol each winter, I am encouraged to see that House and Senate leadership are taking the pandemic seriously and are working with health experts so we can do the work the people of our respective districts elected us to do, while working towards keeping safe all of those who work at the Capitol.

**Why won't I receive a ballot in  
the mail like the June primary?**

Governor Hogan prevented the state board of elections from doing this. Instead he instructed the board to send mail-in ballot applications to all registered voters.

**If I will receive a mail-in ballot  
request form, why should I  
request one on my own?**

Being proactive about requesting a mail-in ballot will help lighten the administrative load being undertaken by the county board of elections.

If you have not updated your address in the state system, your request form may be sent to the wrong address. This will ensure your information is up to date

If you give me your email address, I would be happy to personally send you the online and PDF request form

**SBE has updated the request process, decreasing the number of steps required**

**When should I expect my mail-in ballot request form?**

SBE will start mailing the mail-in ballot request forms on August 24 and hope to finish by August 28 but no later than August 31.

**After I submit my request, when will I receive my ballot?**

The State Board of Elections is scheduled to print ballots in late September, then will be mailed toward the end of the month.

**What if I do not receive a ballot request form in the mail?**

If you have not already requested a ballot, you can call your local board of elections or the state board of elections and they can verify in their system whether there is a request form headed your way.

**Will I have to have an additional envelope and postage ready to return my request form?**

No. The request form will come with a prepaid return envelope. Your ballot will come with prepaid postage as well.

**How do I know if my ballot request was received and processed?**

Visit the voter look-up website to verify if your local board of elections received your request for a ballot and the status of your mail-in ballot. I can also email you the link to the Voter Lookup Tool:

**What is the deadline to request a mail-in ballot?**

The Board of Elections must receive your mail-in ballot application by Tuesday, October 20. But be sure to contact your local board of elections before requesting a new ballot so they may cancel any previous ballot in case it was lost in the system or went to an old address. If voters submit a timely request for a ballot via web delivery, voters can download ballots up until 8:00 p.m. on November 3. (October 30 used to be the deadline to request a ballot if the voter wanted to download the ballot.)

**How do I submit my mail-in ballot?**

Mail your ballot. If you mail your voted ballot, make sure that the envelope is postmarked on or before general election day (Nov 3, 2020). Your voted ballot must be received by your local board of elections by 10 am on Nov 13, 2020. Hand deliver your ballot. You must deliver it to your local board of elections by 8 pm on Election Day, or you may take it to an early voting center or a polling place by the time the polls close. You may also drop it off at a designated ballot drop-off box.



**Can I put a web (email) delivered ballot into a drop-off box?**

Yes. Ballot drop-off boxes can collect both physical ballots sent to you by the Board of Elections OR ballots delivered/downloaded and printed online.

**When is the deadline to submit my mail-in ballot?**

The ballot must be postmarked by Election Day. That means it must be actually picked up by the mail service on Election Day. If the mail carrier has already visited and will not be back until the next day, your ballot will not be postmarked on time even though it was in the mailbox. When in doubt -- on Election Day you can go to a polling location near you/find a ballot drop off box and physically hand in your ballot

**Can I have someone pickup my mail-in ballot?**

Due to the COVID-19 pandemic, you cannot have someone designated to pick up your ballot because the local board of elections are currently closed to the public.

**Where can I find information on the election in Spanish/French/Vietnamese etc.?**

If you go to the State Board of Elections website (elections.maryland.gov) you can click at the top right 'Translate' and there are nearly 100 language translation options for the site.

**Will there be ballot drop-off boxes at Early Vote locations, and Election Day locations?**

Not every location will have a ballot drop-off box. Right now, the State Board of Elections has secured at least 270 ballot drop-off boxes but it's unlikely that SBE has one at every Early Voting and Election Day voting location. The SBE has stated

they will include drop-box locations with your mail-in ballot.

**Can I request a ballot, but decide to vote in-person instead on Election Day?**

Yes, you can. However, if you come to the polls and the Election Judge has on record that you requested a mail-in ballot, they will ask you to vote by provisional ballot so they can later verify the single vote in their system. Even if a voter brings their blank mail-in ballot with them, they will be required to vote provisionally.

**Why does the online form ask for my Driver's License (or State ID) number and the last four digits of my social security number?**

Both of these are required by law for online voting request security only. Paper applications do not require this information for a mail-in ballot sent to you, but would still be required for internet (email) delivery.

**When will I learn where my Early Voting center/ballot drop-off/Election Day voting center is?**

Currently, the SBE has not released an official list of Early Voting centers, ballot drop-off locations, or Election Day voting centers. We have been told SBE will include location information along with voters mail-in ballots.

**How many voting centers will be available on Election Day?**

Local boards are allowed to begin counting as early as Oct. 1. The idea is to allow boards the time they need to get this substantial job done and ensure the returns can be certified by the required deadlines for the electoral college certification.

All results of ballots counted early will be embargoed until the polls close on Election Day. Voters should feel confident that no early results will be released. It would be against the law for local boards to release any early results.

Those needing help can call 211 and press 1 or text their zip code to 898-221.

I urge everyone to stay vigilant in containing this disease. Show others you care about them by wearing a mask. We can get through this, but it may not be soon. So, we must ensure we stay healthy until life-saving treatments are perfected and a vaccine is developed. Contact our office if we can be of assistance in helping you during these extraordinary and "interesting" times.

Another thing we all must do is VOTE. You will be receiving in the mail an application to request a mail-in ballot. Unlike the primary, when a ballot was automatically sent to you, you MUST REQUEST a ballot for the November election. I urge you to fill out that mail-in ballot request as soon as it arrives and then complete and return the ballot as soon as that arrives. I don't think any of us are "undecided" at this point, so don't delay. Get the ballot in and make sure it was received.

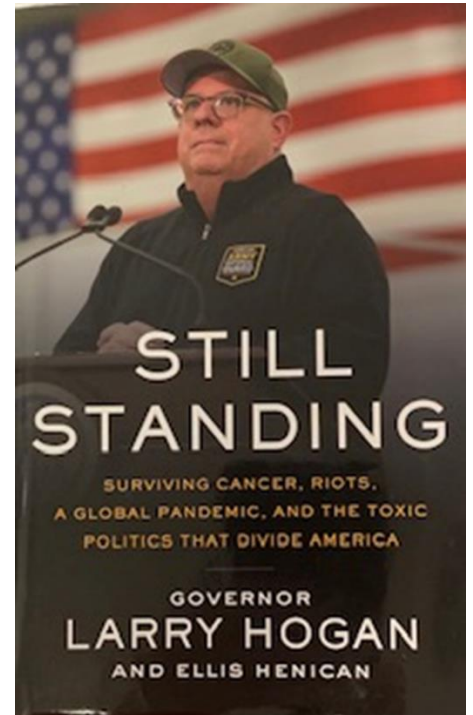
**The Rest of the Story**

Hogan is not One of Us – I have seen on Facebook and heard in other forums from Democrats that Hogan isn't so bad for a Republican. That may be true, for a Republican, but he is not one of us. He is a rock-ribbed Reagan Republican. I know that because I just finished reading his book, *Still Standing*. Before his junior year in college, Hogan served as chairman of Youth for Reagan and was selected as an alternate delegate pledged to Reagan when Reagan challenged President Ford for the Republican nomination for president in 1976. He did that when his father was leading the Ford campaign in Maryland. After college he worked for one of the most conservative Republican members of Congress, John Rousselot. Rousselot was a supporter of the John Birch Society. When Hogan first ran for Governor in 2014, he aped Reagan's appeal to the selfish side of Maryland citizens' character by basing his campaign on one thing – reduce taxes. Reducing taxes after Reagan and incorporated into the Tea Party/Trump Republican message with a heaping of racism, immigrant bashing, and xenophobia, became the piece de resistance of the Republican credo: no vision for the future, no passion for solving real world problems, no compassion for the little guy, no appreciation for the role of government to help people, just let me have more money in my pocket. Hogan has governed just like the Reaganite he is. Thank

goodness, he has had a veto-proof Democratic majority in the Maryland General Assembly.

As evidence of the results of a Reagan-like approach to economics, one can look at an August 19, 2020, article in *The Washington Post* that reports that The Economic Policy Institute “found that the chief executives of America’s 350 largest companies earned an average of \$21.3 million in realized compensation in 2019, setting the ratio of CEO-to-worker pay at 320 to 1, up from 293 to 1 in 2018 and more than five times as high as the 61-1 ratio in 1989.” This is probably not a problem that Governor Hogan would recognize as the *Baltimore Sun* reported on August 14, 2020, that Hogan released tax returns during his 2018 re-election campaign, showing that he and his wife earned a combined \$2.4 million during his first three years as governor. The governor’s salary is \$175,000, but Hogan retains 100% interest in The Hogan Group, plus significant shares in the subsidiaries of the Hogan Company. His holdings are in a trust, but he is allowed to receive updates from the trust. The Hogan Company is still doing business in the State of Maryland.

I will concede that Hogan is not a Trumpite, and he seems to be a capable manager in a crisis. His book demonstrates that he is a profligate self-promoter as well. All politicians have healthy egos, and *Still Standing* demonstrates that Hogan’s more than matches the ego of most politicians. Admittedly, the book is a fairly good read although I am not sure how much that can be attributed to Hogan’s writing style or that of his co-writer, Ellis Henican. According to Hogan, it was he alone who quelled the anger that rose up in the streets of Baltimore after the death of Freddie Grey at the hands of the Baltimore police. In thirty-eight pages Hogan condemns the lack of leadership from Mayor Stephanie Rawlings-Blake, and not once does he mention the heroic efforts of the late Congressman Elijah Cummings to keep peace in his hometown.

I want to take a moment to highlight an excellent decision the Board of Education made last year, which was hiring an Ombudsperson. As noted on the FCPS website, “the Ombuds...is a neutral person designated by the Board of Education to informally help provide options for resolution of an FCPS concern or issue.” If you are struggling with an issue with our schools, please reach out to her, by email at [Ombuds@fcps.org](mailto:Ombuds@fcps.org) or by phone at (301) 696-6852.

In her annual report, the Ombuds summarized the most frequent concerns brought to her office. A plurality of these concerns involved special education, including unmet goals within students’ Individualized Education Plans (IEPs). And so, I repeat what so many of us already know: We must improve special education in Frederick County. We cannot accept a scenario in which students are forced to leave the county to receive a free appropriate public education. We must invest in best practices in Frederick. I have seen special education from several perspectives: family member, special education teacher, and college disability services staff. I know we can do better. And I know legally and ethically we must do better.

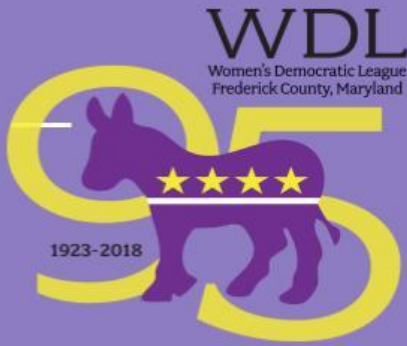

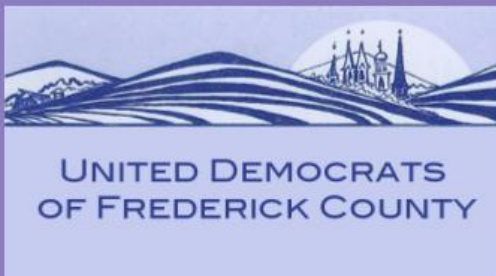

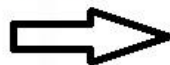
