Save the date: The (mostly) annual Frederick County Democratic Gala is scheduled for Monday, June 9, with keynote speaker Senator Chris Van Hollen. We're so excited to be back in person after a two-year hiatus! Details are still being finalized, but this year's event will be at Dutch's Daughter, and the \$90 price per guest will include a glass of champagne or cider for a special toast during the program. The ticket link will go live soon, but be sure to mark your calendar now.

Tickets are, however, currently available for the first TWO Plow-Fish events of 2022. On May 9 and May 23, we'll get to know both Democratic Attorney General candidates, Judge Katie Curran O'Malley and Congressman Anthony Brown. If this is new to you: the Monocacy Plowman and Fisherman Club (Plow-Fish) is one of the fundraising efforts of the Frederick County Democratic Party, where you can get face-to-face with elected leaders and leading Democrats from around the state - but every dollar stays in Frederick County to help get local Dems elected. Members have several options:

Pay \$150 now (or \$140 if you're a monthly sustainer), and receive two tickets each to all three events for the year

Pay \$120 (or \$110 if you're a monthly sustainer) if you want to skip the first one and attend the last two

Pay \$75 per event if you want to attend just one

The second Saturday is the Western Maryland Democratic Summit, so the North County club will meet on the third Saturday, May 21. South County will then meet on the fourth Saturday, May 28. This year's primary will be July 19, and it's particularly crucial that we all get out and vote in the Board of Education race. It would be great if we could eliminate as many of them as possible in the primary and not even have to worry about the possibility that they'll be elected in November. So please, advocate for your chosen candidates; give them your time or donate to their campaigns. Hand out their literature. Write postcards. Make phone calls. Host a meet & greet. You don't want to be stuck with four scary, obscene people on the Board of Ed.

SENATOR RON YOUNG



The following is a summary of the Maryland General Assembly's 444th Legislative Session. A full list of the legislation I introduced and co-sponsored (*) can be found at <https://mgaleg.maryland.gov/mgawebsite/Members/Details/Young>.

The bipartisan Senate Joint Resolution* ([SJ011](#)) confirmed that the Maryland General Assembly stands in solidarity with the people of Ukraine as they resist the unprovoked Russian invasion. Passing the Gas Tax Holiday bill ([SB1010](#)) supported sanctions on Vladimir Putin and the Russian oligarchs while easing the financial burden on Marylanders.

In overriding the Governor's veto of the The Time to Care Act* ([SB275](#)) Maryland joins nine (9) other states and the District of Columbia in providing a family and medical leave program.

This fall voters will be asked to decide if recreational cannabis* should be legal per a Referendum to amend the Maryland Constitution ([HB1](#)). Some parts of the bill, including, allowing Cannabis businesses the same tax deductions as other Maryland businesses (my bill ([SB333](#))) go into effect June 1, 2022.

As required by the Maryland Constitution, the General Assembly passed a balanced operating budget bill ([SB290](#)) and capital budget ([SB291](#)), of \$61 billion in appropriations for FY2023, maintains \$2.6 billion in cash resources, and \$211 million in the General Fund.

Brynleigh's Act - Seizure Action Plans ([SB299](#)) requires the inclusion of a seizure action plan to the current

public standards and guidelines regarding emergency care for students with special health needs.

Returned Peace Corps Volunteers In-State Tuition ([SB050](#)) allows Marylanders that served in the Peace Corp to restore their in-state status upon returning to Maryland.

Funding of Regional Resource Centers and Libraries ([SB448](#)) increases the per capita funding amount that must be provided to each regional resource center and county public library system beginning in fiscal 2023.

The Climate Solutions Act of 2022 ([SB528](#)) Resets the goals for reducing Maryland's emissions of greenhouse gasses by 60% by 2030 and reaching net neutral emissions by 2045.

The Great Maryland Outdoors Act ([SB541](#)) builds a world-class state park system by addressing overcrowding and understaffing, clearing a deep backlog of critical repairs, increasing recreational water access and creating new state parks.

Maryland Clean Cars Act ([HB1391](#)) extends the vehicle excise tax credit for purchasing zero-emission vehicles and a grant program for zero-emission medium and heavy duty vehicles.

Plug-In Electric Drive Vehicles Parking Spaces ([SB146](#)) establishes standards of use for plug-in vehicle parking spots.

Grant Program to Reduce and Compost School Waste ([SB124](#)) is a grant program for county boards of education and public schools to develop programs for reducing food waste and composting of pre-and post-consumer waste.

Old growth forest protection ([HB884](#)) prohibits logging on roughly 410 acres of select Department of Natural Resources-designated old-growth forests on state-managed lands.

Diapers and Baby Products Tax Exemption ([SB316](#)) eliminates the sales tax on diapers, baby wipes, baby bottles, and infant car seats.

The Behavioral Health Crisis Response Services ([SB241](#)) establishes the 9-8-8 Trust Fund to support the universal telephone number for the national suicide prevention and mental health crisis hotline.

Elderly and Handicapped Transportation Service ([SB838](#)) ensures the Statewide Specialized Transportation Assistance Program receives consistent funding.

Instant Ticket Lottery Machines for Homeless Veterans Act ([SB155](#)) aimed to significantly reduce veteran homelessness in Maryland by raising over \$1 million annual for such programs.

Retirement income subtraction modifications and Senior credit ([SB405/](#)[HB1468](#)) reduces Maryland income tax for all people aged 65 and older at \$1,000 tax break for single people earning \$100,000 or less and a \$1,750 tax break for couples earning up to \$150,000.

Restoration of Honor Act ([HB1380](#)) reinstates an honorable discharge to a military veteran that was discharged due to sexual orientation or gender identity.

Threats to Public Officials ([SB956](#)) adds public officials, election administrators to the list of public officials it is illegal to threaten. It subsumes a similar bill that I sponsored ([SB298](#)).

The Maryland Regional Rail Transformation Act ([SB514/](#)[HB 778](#)) expands the MARC commuter lines Brunswick, Camden, and Penn Line trains to run all day, in both directions, and to extend service into Western Maryland, Arlington, VA, and Newark, DE.

Maryland Deaf Community Center (MDCC) \$2.5 million for the establishment of a statewide, permanent home for a Deaf Community Center. We are deeply honored that Maryland's Deaf community chose Frederick as the home for their community center to offer programs and services for all ages of Maryland's deaf citizens.

Disposition of Marriage Ceremony Fee ([SB649](#)) directs a portion of the marriage fee to Heritage Frederick - the official repository of Frederick County's marriage records.

Between Bond Initiatives and Supplemental Budget funding, Frederick County will receive an additional \$34.6 million for community projects - \$31.0 million for District 3 projects such as:

African American Graveyard Restoration \$25,000
"Lefty" Kreh Memorial \$50,000
City of Frederick Bridge Mural repairs \$ 250,000
Rose Hill Manor Park \$500,000
YMCA - City of Frederick and Urbana \$ 750,000
Frederick Innovation Technology Center \$1,000,000
MD School for the Deaf building repairs \$9,582,000
Hood College Repairs \$6,838,000
City of Frederick Police facility \$4,250,000

For FY2023 direct State aid to Frederick County will increase by \$44.2 million over FY2022's funding, a change of over 12%. Frederick County is #1 in State Direct Education Aid and the percentage change in student enrollment and #2 in local wealth per pupil.

I strongly believe that the 2022 session was the most productive that I have experienced during my eight years in the MD General Assembly. The State's FY 23 state operating budget passed with a record \$2.4 B in the Rainy Day Fund for emergencies and provides more than \$650M to fund the General Assembly's legislative priorities like education, Marylanders with the greatest need, employee benefits, and cost of living increases for state employees.

This year's capital budget is one of the largest in State history. Frederick County benefited greatly with major allocations to public school construction, Maryland School for the Deaf, Hood College, the Asian American Center, Program Open Space, and the Crisis Stabilization Center.

This year I introduced some major legislation to increase access to health care. I am proud to announce that several of these issues passed and received sizable funding. A summary of the initiatives that I spearheaded is as follows:

Behavioral Health Crisis Response Services-9-8-8 Trust Fund establishes the trust fund to provide reimbursement for costs associated with designating and maintaining 9-8-8 as the universal telephone number for the national suicide prevention and mental health crisis hotline. It develops and implements a statewide initiative for the coordination and delivery of the continuum of behavioral health crisis response services. In fiscal 2024, the Governor must include \$5.5 million in the annual budget bill for the trust fund.

Developmental Disabilities Administration (DDA)-Self-Directed Services- The Self-Direction Act of 2022 requires the DDA, in consultation with stakeholders, to establish and provide training materials to coordinators of community services (CCSs) specifically on the self-directed services model of receiving services. As part of developing a "person-centered plan of service," a CCS must educate the recipient on all models of service available to the recipient, as specified. Also, this legislation will increase overnight support as well as the number of hours for the utilization of Support Broker services. Pharmacists Administration of Injectable Medications for Treatment

of Sexually Transmitted Infections- requires insurers, nonprofit health service plans, health maintenance organizations, the Maryland Medical Assistance Program, and the Maryland Children's Health Program to provide coverage.

Elderly and Handicapped Transportation Service County Funding- County Executive Gardner has been asking for supplemental funding to meet the demand for several years. This year, and going forward, we were able to acquire additional funding based on the cost of living increases.

Helping Marylanders with Dementia- Our state's fiscal 2023 budget includes \$3.5 million to provide funding for enhanced Alzheimer's services and research.

These initiatives will go a long way in achieving my mission to focus my support on assisting the most vulnerable among us.

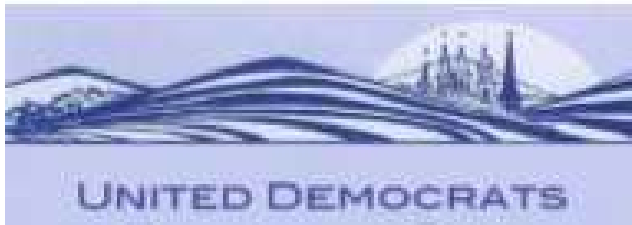

POLITICS AND THE PETER PAN INN

Some of those that have been around a few years have fond memories of the Peter Pan Inn. The Peter Pan Inn, in Urbana, opened in 1926 and closed in 1986. It was located right in the center of what was the sleepy village of Urbana. Today Urbana is a sprawling, busy, hubbub of houses of all types, restaurants, a local branch of the county library, and lots of commuters scurrying around on the way to or from jobs “down the road.” Before the “new Urbana” the only reason most people came to Urbana was to visit the Peter Pan Inn. Richard “Dick” Baumgardner’s mother started the restaurant in an old house that she paid \$10,000 for. My wife’s grandmother grew up in that old house on Route 355. A tavern had occupied the property as far back as 1800. Over time Grace’s son, Richard, a musician, singer, and aspiring vaudevillian persuaded his mother to establish an art-deco nightclub on the property known as the “Hot Cha Cha Club” at Peter Pan Inn. When Grace died in 1947 Dick expanded the restaurant, and it became known for the peacocks strolling outside, outdoor statues, fancy drinks in hurricane glasses, and “old world” style, especially in the Peacock and Garden rooms. It was described as “eclectic and gaudy.” The menu was served family-style including a relish tray, fried chicken and shrimp, ham, steak, hush puppies, beets, peas in butter sauce, and boiled potatoes. Sometimes the wait to get a table lasted hours, but patrons could stroll the grounds drinking Planters Punch and watching the peacocks. I remember when students from Montgomery and Frederick County schools would hold their prom dinners there.

Eventually, Dick Baumgardner opened another traditional restaurant in Clearwater, Florida, called Baumgardner’s, and a fine dining establishment called The Kapok Tree Inn, which featured five dining rooms and seating for 1,300 as well as a wedding chapel. Richard Baumgardner died in 1976. The Kapok Tree Inn was named one of the Top 100 Restaurants in America that year. After Dick’s death, his restaurants closed due to family quarrels and economic conditions. The Peter Pan Inn closed its doors in 1986. It was replaced by The Cracked Claw, a seafood restaurant and off-track betting parlor owned by the Poole family, which occupied the Peter Pan Inn space from 1989 to 2011.

The Peter Pan Inn’s political connection is two-fold. First, Richard Baumgardner, a very civic-minded individual, also decided to become involved in politics. He ran as a Republican for the House of Delegates from Frederick County in 1950 and was elected along with 4 other Republicans (Horace Alexander, Melvin Derr, S. Fenton Harris, and Joseph Payne) and one Democrat (C. Clifton Virts). At that time Frederick was not divided into legislative districts and had one state senator (Republican Jacob R. Ramsburg) and six members of the House of Delegates. Baumgardner served in the House of Delegates from 1951 to 1954 but did not run for re-election. Republicans outnumbered Democrats in voter registration in Frederick County in the early 1950s.

The other political connection associated with the Peter Pan Inn was that it was the location of many political meetings and dinners over the years. The last major political event that took place at the Peter Pan Inn was the Jefferson-Jackson Day dinner (the precursor to today's Democratic Gala) which was held there on May 12, 1978. 425 party regulars attended that dinner. What was most notable is that many statewide candidates attended but left early before they had a chance to speak. I was there and what I remember most was the long lines at the bar. Comptroller Louis L. Goldstein was the only state candidate who stayed around long enough to speak. The newspaper reported elected officials who were present – only Galen Clagett, Ron Young, and Charles Smith (former Maryland State Delegate from Brunswick) are still alive. Prior Jefferson-Jackson Day dinners were held at the Peter Pan Inn in 1964 with Maryland Attorney General Thomas B. Finan as the speaker, in 1965 with numerous candidates for Maryland Governor speaking (A.G. Thomas B. Finan, Congressman Carlton Sickels, and Comptroller Goldstein), and in 1966 with Congressman John Tunney (son of heavyweight champion Gene Tunney) as the featured speaker. The Women's Democratic League of Maryland held its spring meeting there with Assistant Secretary of Labor Ester Peterson as the speaker. The Republicans held their Lincoln Day dinner at the Peter Pan Inn in 1962, 1974, and 1976. At the 1962 Lincoln Day Dinner, Republican National Committee Chairman William Miller, who was to become the Republican nominee for Vice President in 1964 was the speaker, and Congressman Barry Goldwater, Jr. was the speaker at the 1974 Lincoln Day dinner.

CANDIDATE: STEPHEN SLATER



I am very pleased to introduce myself as a candidate for the Maryland House of Delegates for District 3. I am running because I love this district and I have a unique set of skills and experiences to enable me to serve District 3 in Annapolis.

First, I have lived here my whole life – from being born at Frederick Memorial Hospital to attending elementary school at South Frederick (now Lincoln) Elementary, then middle and high schools at West Frederick Middle and Frederick High Schools. For the past two decades, I have been a practicing attorney in downtown Frederick. Living here for more than fifty years and raising my family here gives me a perspective on this district and the needs of the citizens, those that have lived here as long as I have, and those that have recently come to Frederick.

Second, I have a lifetime of public service and of giving back to Frederick that I want to continue in Annapolis. It started when I joined the U.S. Navy while still in high school and spent six years defending our nation serving onboard the aircraft carrier U.S.S. Enterprise. While in college, I continued my military service in the Maryland Army National Guard, serving in the infantry unit based at the Frederick Armory for three years. When I got out of the Navy, I got together with some other young Democrats in Frederick and we reconstituted the Frederick County Young Democrats, where I was elected President of that organization. I then became very active in the Young Democrats of Maryland, being elected Treasurer, Vice-President, and then President of that organization. After working on Capitol Hill for Senator Sarbanes when he represented Maryland in the U.S. Senate, I became active in the United Democrats of Frederick County, serving as Secretary, Vice-President, and eventually President. Later, I was elected by the Democratic voters of Frederick County to two terms on the Frederick County Democratic Central Committee, serving as Secretary and Vice-Chair of that body. Each of these proven leadership experiences has given me

knowledge and skills that will serve me well in the Maryland House of Delegates.

As the son of two former Frederick County Public School teachers (and the brother of a current FCPS teacher), education has always been an important part of my life. When I joined the U.S. Navy while still attending Frederick High, my educator parents made me promise that I would continue my higher education. After completing Naval Nuclear Power School and six years in the Navy, I was fortunate enough to attend the University of Maryland at College Park on the G.I. Bill, earning my Bachelor's degree in Government and Politics. From there I went on to Georgetown University for law school and earned my J.D. in 2002. I firmly believe that quality and accessible education is so vital to all aspects of our community with regard to economic opportunity, upward mobility, and social justice. Along those lines, a quality education starts with universal pre-school available to all, continues with quality K-12 education, and culminates with the low- or no-cost college for any deserving student. To me, quality K-12 education means three things: good facilities in all school districts, well-compensated (and appreciated) teachers and school staff, and a curriculum designed for success. For post-high school education, we cannot emphasize enough the importance of our community colleges, and we have a gem right here in Frederick with F.C.C. I plan to take these goals with me to Annapolis.
