Your municipal leaders had the opportunity to attend the June Maryland Municipal League Conference (MML) with other local officials, cabinet secretaries, candidates, and members of the Maryland General Assembly. I attended a series of meetings to learn more to advance our Democratic initiatives - from sessions on public speaking to equity in climate resilience to property taxes and so much more.

The MML Conference Opening Session featured author and speaker, Will Bowen. Maryland Proud

I thought that my July article would be my final pitch to be the Democratic choice for the Maryland State Senate in District 3. However, I cannot make that case any better than [Diana Halleman did in her 6/24 LTE](#).

Instead, this week's national news reminded me of how proud I am to serve in the Maryland General Assembly. While much of the country is going back in time, Maryland is a shining star of progress.

Over the last decade, Maryland has been at the forefront of firearm safety policies and has enacted several important bills to address firearm violence and protect the State's residents. Here are a few from the 2022 session:

> Chapters 18 and 19 of 2022, Public Safety – Untraceable Firearms: Chapter 18 and 19 of 2022 (Senate Bill 387), a part of the Senate's community safety plan, prohibited a person from purchasing, receiving, selling, offering to sell, or transferring an unfinished frame or receiver unless it has been imprinted with a serial number by a federally licensed firearms manufacturer or federally licensed firearms importer. A person may not sell, offer to sell, or transfer a firearm unless it is imprinted with a specified serial number.

> Chapter 55 of 2022, Public Safety – Licensed Firearms Dealers – Security Requirements: Chapter 55 (House Bill 1021) prohibited a firearms dealer from conducting business and storing firearms at a location unless (1) the premises on which the licensed dealer operates is equipped with specified security features or (2) outside business hours, the licensed dealer locks all firearms stored on the premises in a vault, a safe, or a

room or building that meets specified requirements.

> Chapter 142 of 2022, Crimes - Firearms and Inmates - Enforcement, Procedures, and Reporting: Chapter 142 (Senate Bill 861), a part of the Senate's community safety plan, established the Maryland State Police Gun Center within the Department of State Police (DSP) as a statewide firearms enforcement center for the tracking, screening, and vetting of all firearm crimes committed in the State.

The Abortion Care Access Act establishes the categories of Qualified providers that are authorized to perform an abortion in the State to include physicians, nurse practitioners, nurse midwives, licensed certified midwives, physicians assistants, and any other individual for whom the performance of an abortion is within the scope of the individual's license or certification. It established the Abortion Care Clinical Training Program and a related special fund, for which the Governor must appropriate \$3.5 million annually. HB937 requires Medicaid and health insurance carriers to provide coverage for abortion care services and requires the Maryland Health Benefit Exchange to provide a subsidy under the State-Based Young Adult Health Insurance Subsidies Pilot Program to cover 100% of the cost of the premium for young adults who have a 0% expected contribution under the subsidy eligibility and payment parameters for the pilot program in calendar 2023.

In light of the Supreme Court decision, this legislation enables us to assist those who are denied reproductive freedom in neighboring states.

The primary election will take place on July 19. It is always interesting to look back to the last election to try to make predictions about the upcoming election. Although more relevant for the general election, one significant change from four years ago is that Democrats are on the rise in Frederick County. In June 2018 there were 66,138 registered Republicans, 62,609 registered Democrats and 40,366 registered Non-partisan voters, giving the Republicans a 3,529 advantage over Democrats. As of June 1, 2022, Frederick County Democratic registration was 75,658 and Republican registration was 67,740. Non-partisan registration was 48,526. Democrats now have a 7,918 advantage!

In the 2018 primary election in Frederick County, only 18,889 Democrats voted, 2,095 more than the 16,794 Republicans who voted. On July 19, 2022, the consensus is that the turnout will be lower due to the fact that the date has been changed and primary election day is in the middle of summer.

In 2018, in Frederick County, the Ben Jealous and Susan Turnbull ticket received 1,723 votes with Baker-Embry following with 821 and Vignaraja-Blake at 585. In July, Peter Franchot, Tom Perez, and Wes Moore seem to be the frontrunners, but we shall see if the prognosticators are correct. Ben Cardin had no problems with re-nomination for the U.S. Senate in Frederick and in the State of Maryland and it appears that Senator Chris Van Hollen should also have no problems in the primary or in November.

Congressman David Trone should easily get through the primary but faces a tough re-election fight due to re-districting. Four years ago incumbent Comptroller Peter Franchot and Attorney General Brian Frosh ran unopposed in the primary, but this year former Judge Katie Curran O'Malley and Congressman Anthony Brown are competing to succeed Brian Frosh as Attorney General. In addition, Delegate Brook Lierman and Bowie Mayor Timothy Adams both want to succeed Peter Franchot as Comptroller of Maryland.

As is the case in this primary, the nomination for the State Senate in District 3 was competitive four years ago. Incumbent Ron Young (4,717) edged out competitors Jennifer Dougherty (3,611) and Jennifer Brannan (2,549). With Senator Young's retirement, Delegate Karen Lewis Young and Board of Education member Jay Mason are vying for the Senate nomination in July. It is difficult to compare this year's primary in Maryland House District 3 because four years ago we had districts 3A and 3B. In 2018 Ken Kerr ran unopposed in 3B and incumbents Karen Lewis Young and Carol Krimm were challenged in 3A by Ryan Trout with two seats in play. Final primary results: Young – 5,393, Krimm – 4,460, Trout – 2,034. This year's primary in District 3 for three seats is a hotly contested race with seven contenders and only Ken Kerr being an incumbent.

There was not a contested Democratic primary four years ago for County Executive, Maryland House District

4, or any of the council districts except for At-Large. Four Democrats competed for the two at-large nominations with Kai Hagen (10,235) and Susan Reeder-Jesse (7,836) prevailing over Kavonte Duckett (5,098) and Galen Clagett (4,123). In this year's primary, there is no contest for the Democratic nomination for At Large, District 1, District 2, or District 5. In District 3, Jasmin Di Cola is challenging incumbent M.C. Keegan-Ayer, and four candidates are competing to succeed Jessica Fitzwater in Council District 4: Nicholas Augustine, Kavonte Duckett, John Funderburk, and Betty Law.

One of the most hotly contested and important races in this year's primary is for the Frederick County Board of Education, which is non-partisan. The 2018 primary involved thirteen candidates with eight going on to the general election. The eight who survived the primary included Brad Young – 19,413, Karen Yoho – 13,176, Jay Mason – 12,932, Liz Barrett – 12,396, April Miller – 10,703, Cindy Rose – 9,770, Camden Raynor – 9,172, and Kim Williams – 5,094. Not going on to the general election were Marie Fischer-Wyrick – 5,609, Edison Hatter – 4,132, Masai Troutman – 3,837, Jonah Eisenberg – 3,805 and Chaz Packan – 3,370. Nancy Allen, Olivia Angolia, Liz Barrett, Ysela Bravo, David Brooks, Heather Fletcher, Rae Gallagher, Mark Joannides, April Montgomery, Ashley Nieves, Tiffany Noble, Rayna Temondini, Cindy Rose, Dean Rose, Justi Thomas, and Karen Yoho are on the ballot for the Board of Education. While non-partisan, six are registered as Democrats: Liz Barrett, Ysela Bravo, David Brooks, Rae Gallagher, Dean Rose, and Karen Yoho. Please vote for four of them.

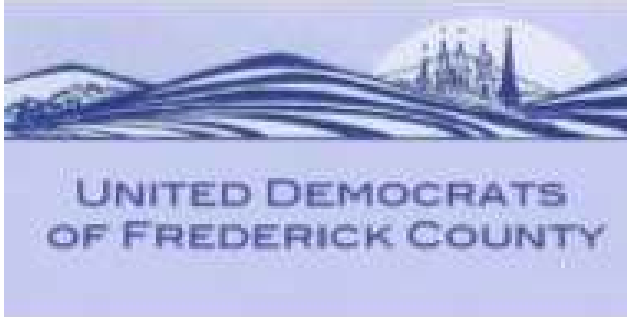
All of the courthouse races (Clerk of the Circuit Court, Register of Wills, Judge of the Orphans' Court) are uncontested this year as was the case in 2018. In 2019 Karl Bickel ran unopposed for sheriff whereas this year he is competing against Daniel McDowell. With regard to the Democratic State Central Committee election in 2018, eight women ran for six positions and ten men ran for six positions. The results in regard to women: Lauren Beacham – 8,554, Deborah Carter – 8,385, Deborah Reynolds – 8,156, Mari Lee – 8,120, Renee Knapp – 7,671, and Maggie Hayes – 7,282 outpolled Kaitlynn Sumpter – 6,604 and Mary Milam – 5,880. With regard to the men, the results: Antonio Bowens – 7,145, Josh Cramer – 6,795, Gene Stanton – 6,652, Tom Slater – 6,036, Billy Reid – 5,840, Tony Soltero – 5,799. These six men edged out Mike

Sowell – 5,541, Chris Izzo – 5,297, Tom Gill – 4,640, and Jay Smathers – 4,246. The Central Committee has been expanded to fourteen members, and only thirteen persons have filed, so the race is uncontested.

Good luck to all of the Democratic candidates. On to victory in the general election!



In memoriam – We note the passing of Paul E. Weinsengoff. Paul was a long-time Democratic member of the Maryland House of Delegates, representing Baltimore City for 27 years from 1966 to 1994. He was 89 years old.

Both men were very gracious to make the time for us and answered all the questions with class. Frederick County would be fortunate to have either person as the next sheriff over the current incumbent. There are small differences between them, but they both agreed the current Sheriff has mismanaged the office leaving us vulnerable. There are currently 22 openings in FCSO (Frederick County Sheriff's Office), which means a 2-3 people calling in sick could leave the office completely short-handed and unable to properly service the county residents. Please take the time to learn more about each candidate on their websites and don't forget to vote in the primary on Tuesday, July 19 th . The Democratic party is so lucky to have so many great candidates running to represent us.

Be sure to vote all the way down for every single office. There are no unimportant offices. For example, did you know the main job of the Orphans' Court is to supervise the management of estates of people who have died – with or without a Will – while owning property in their sole name. It has authority to direct the conduct of personal representatives, has jurisdiction over the guardianship of the property of minors and in some counties, appoints guardians of minors. We have three great candidates running for the three spots on the Orphans' Court, Bonnie Nicholson, Michael Powell, and Marvin Schwab.

Finally, the UDFC Summer Picnic is back for the first time since 2019! This year's picnic will have numerous candidates for office in attendance and some fun games for all. We will be at Kemptown Park Shelter #2 on Saturday, July 9 th from 4-6pm. Admission is free for members and \$20 for non-members
