# CHAIR'S CORNER

Well, the primary is (mostly) over, although the results have not yet been certified as I write this, and there is at least one race where a recount may happen. But for the most part, we are forging ahead to November 8, and there is much you can do to help in the next 99 days (not that we're counting).

A few interesting turnout numbers: In the county executive race, 23,214 Democrats cast votes, compared to 17,227 Republicans. The race for sheriff showed a similar pattern. Of course, Michael Hough and Chuck Jenkins were uncontested, but let's look at County Council district 1, where Republicans did have a contested primary, and Jerry Donald ran unopposed. He still garnered almost 300 more votes than the two Republicans combined. We can absolutely keep all the seats we have now and pick up a few more if this trend continues. It falls to all of us to ensure that it does.

I'd like to thank all the Dems who put their names on the ballot and campaigned their hearts out over recent months. I know how much work you put in, and I hope you will all stay engaged - help us win in the general election this year, of course, but also please consider another run in the future. A congressional representative once told me that the biggest mistake a first-time candidate makes is giving up after one unsuccessful campaign.

We've dubbed this Unity Week, and we'll be out in the community for several events. You can find us tomorrow at four different locations for National Night Out: Carrollton Park, Hill Street Park, Lucas Village, and Mullinix Park. On Thursday, August 4, we're holding a Unity Rally and Ice Cream Social at the Baker Park band shell, starting at 6:00 p.m. Most of our candidates will be there, along with Maryland Democratic Party chair Yvette Lewis - and we hope you will be there, too. All are welcome!

And on Saturday, August 6, join us in our office at 1080 West Patrick to launch our coordinated canvass efforts on behalf of all our local Democratic candidates. It is of course encouraging to see that more Democrats than Republicans cast primary ballots last month, but we can't take anything for granted. Let's turn out every single Dem voter in November and engage unaffiliated voters as well! If you can't make it this week, be sure to keep an eye on our calendar at [frederickdemocrats.org](http://frederickdemocrats.org) for updates.



We all need to rally behind Jessica Fitzwater now, as both Kai Hagen and Daryl Boffman have already done so graciously. You can reach out to her campaign at <https://www.jessicafitzwater.com/> to volunteer or make a donation. We are facing a formidable and very well-funded opponent in Michael Hough (he's already running ads on MSNBC), so every vote, every phone call, every dollar is needed.

We also need to fight hard to elect a sane Board of Education. Only three members of Cindy Rose's "Hate Slate" made it through the primary, so they will fortunately not be able to get a majority on the BoE no matter what else happens, but even one of them could cause significant damage over the next four years. If you know anyone who ignored that race in the primary, please reach out to inform them what's at stake.

Finally, you may have noticed that the new Central Committee is one human short of a full complement. When they're seated in November, one of their first items of business will have to be filling that final spot. As luck would have it, the new member can be male, female, or non-binary, so they'll be able to choose the very best applicant regardless of gender. If you think you might be interested, get to know the job now. Attend a Central Committee meeting, volunteer in the office, join a phone bank. We look forward to seeing you!

Finally, I'd like to point out the very gracious words and acts

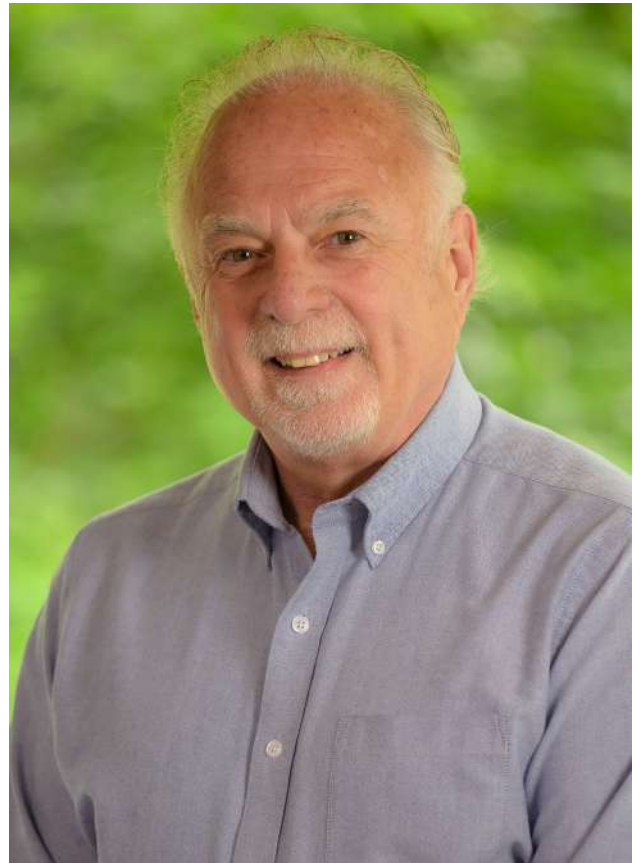

The Democratic Primary race for District 3 Delegate saw an abundance of great candidates. All seven worked hard and competed for every vote. We all got to know each other during the campaign, and I would have been proud to serve with any of the other 6. When all the votes (well—almost all as of today) were counted, I came out on top along with Kris Fair and Karen Simpson.

It's hard to lose. Kris, Karen, and I have all lost elections. It hurts. And I hope that this loss does not deter the other four great candidates from running again in future elections.

Looking ahead to November, I like our chances. The republicans have only fielded two candidates to compete for the three seats. Kathy Deiner was “Designated by Central Committee” on 04/27/2022 after the filing deadline saw only one candidate, Justin Wages, officially file.

Deiner is an Air Force Veteran who is an attorney living in Ballenger Creek since 2009. She is running in response to “government malfeasance” and “power grabbing” during COVID. So, as I said, I like our chances in November, but we can't take anything for granted. Kris, Karen, and I have spoken since the primary and will work together to ensure we are all seated in the House of Delegates when the 2023 session begins on January 11th.

# THE “CRAZIES” ARE AMONGST US: PART II

The voters have spoken. Since the final results from mail-in voting will not be known until later, I will defer discussion of the Maryland primary results until my next column, in the September issue of The Banner. What we do know, as I write this column, is that Maryland Republicans have gone crazy and nominated Dan Cox for governor and Michael Peroutka for Attorney General. We all know that Cox is as Trumpy as one can get and has tried to impeach Republican Governor Larry Hogan. Peroutka is a 70- year old former member of the Anne Arundel County Council, who was defeated for re-election in the Republican primary in 2018. He was the Constitution Party candidate for President of the United States in 2004. He accepted the endorsement of the League of the South and based his campaign for President on America’s Christian heritage, including total opposition to abortion without exception. He is opposed to any funding of education by the federal government. On December 6, 2012, the Human Rights Campaign called Peroutka an “active white supremacist and secessionist sympathizer” due to his links to the League of the South. Brian Griffiths is a Republican

who publishes The Duckpin.com. He was chair of the Maryland Young Republicans for four years and served four years on the executive committee of the Maryland Republican Party. Upon hearing of the victories of Cox and Peroutka in the July primary, Griffith announced that he was going to change his party registration from Republican to unaffiliated. In his blog, on July 20, he said that Republican voters had “nominated candidates for Governor and Attorney General who are wholly unqualified for office and completely incapable of winning.” He described the nomination of Cox and

Peroutka as “the ultimate act of self-immolation” by the Republican Party of Maryland.

In my June column “The ‘Crazies’ are Amongst Us: Part I,” I highlighted the fact that the current Republican Party has become radicalized and bizarre. I used the strange positions taken by Maryland Republican Congressman Andy Harris as an illustration of the fact that, with some exceptions, the Republican Party has become the “Trump Insurrectionist Party.” After that column was published it has been reported that Congressman Harris was among a small group of Republican insurrectionists who met in the oval office with President Trump after the election to plot to overthrow the results of a fair election.

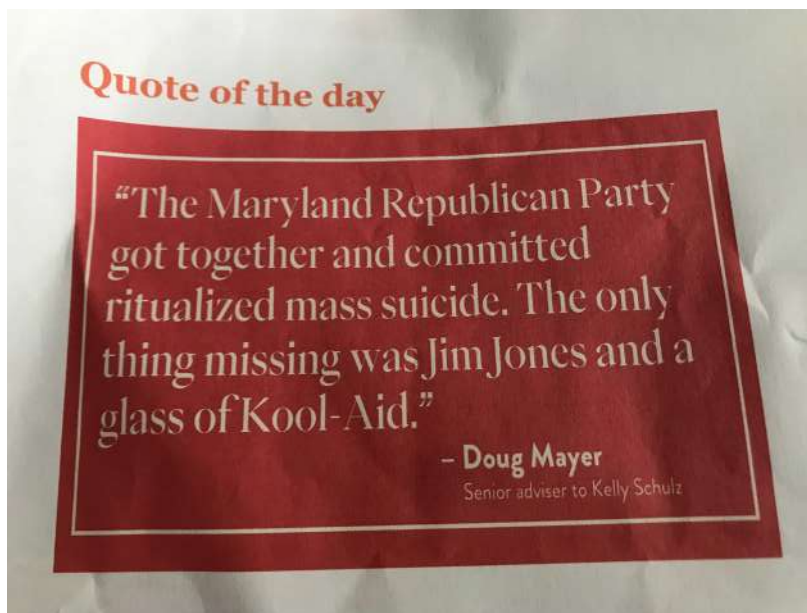
Martin Schram, in an op-ed column entitled “A party without shame,” described how the “MAGA wing of the GOP has erupted in yet another round of hate-based onslaughts and outbursts that seem deliberately calculated to Make America Great Again.” In his column he describes how the Texas Republican Party, at its June convention, adopted extreme resolutions calling for Texas to secede from the union, describing homosexuality as “an abnormal lifestyle choice,” and declaring that President Joe Biden was not legitimately elected. In Missouri, Republican candidate for governor, Eric Greitens released an ad, posing with a shotgun, stating that “Today we are goin’ RINO hunting... Get a RINO hunting permit. There’s no bagging limit, no tagging limit, and it doesn’t expire – until we save our country.”

The craziness of the current Republican Party is omnipresent. Frederick Republican Sheriff Chuck Jenkins has been quoted as saying “I belong to a national organization of sheriffs and we all believe that our primary responsibility as sheriffs is to protect the public from the federal government.”

Recently he said on WFMD, “Every Democrat in America is trying to destroy this country. I really believe that.” He also told the local Republican club that he believed that Biden stole the 2020 election. These are not the statements that a rational, reasonable public servant would make.

Recently Judy Burdette wrote a Letter-to-the Editor of the local newspaper, indicating that she was a Republican and urging Republicans to “choose moderate candidates who will have a chance of winning in the general election.” Local and state Republicans do not seem to be heeding her advice. State Senator Michael Hough was unopposed for nomination as the Republican candidate for County Executive for Frederick County. Before the primary election, Hough ran ads on television that tried to portray him as the voice of reason and a person who could work across party lines. Not so. Hough is a radical Republican who, if elected, will set Frederick County back. Even after four years to see what kind of person President Trump was, Hough supported him for re-election in 2020. In my October column in The Banner, “The Crazies” Are Amongst Us, Part III, I will elaborate on why Hough is too radical to be elected County Executive despite the veneer of respectability he wraps around himself. Republican extremism must be emphasized

in the upcoming election.

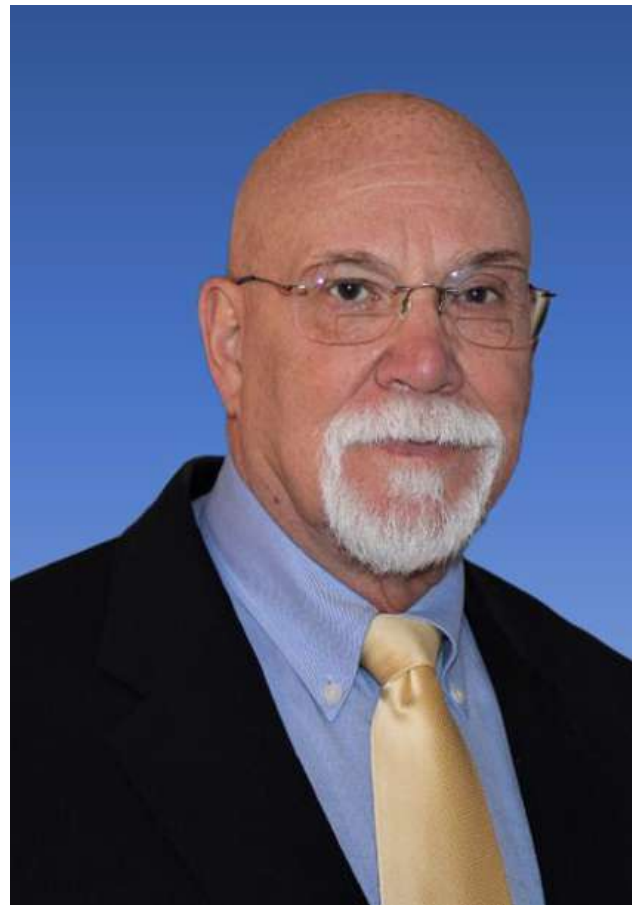

# ANTHONY BROWN

I'm Anthony Brown, and I'm the Democratic nominee to become Maryland's next Attorney General.

With nearly three decades as an attorney, and experiences ranging from a Colonel in the United States Army to a three-term member of the United States Congress, I know that an Attorney General can either be a champion for progress or a defender of the status quo. As your Attorney General, I will be a champion for all Marylanders who will never back down from a challenge.

I was raised by immigrant parents who instilled in me the value of service to others. My father was a doctor who treated patients in some of the poorest hospitals and neighborhoods near where I grew up, and I recognized the difference that my father and later myself could make in the lives of those in need.

Throughout my years in public service, I've advocated for greater equity and justice throughout our state. As Maryland's Lieutenant Governor, I led the fights to repeal the death penalty, decriminalize marijuana, and give Marylanders a second chance. I worked with the General Assembly to expand protections for victims of domestic violence, abused and neglected children, and veterans whose mental and behavioral health needs were not being met.

As a lawyer, I've consistently defended the most vulnerable. I represented clients who have been victimized

by sexual harassment, and stood up for children in need of assistance and the vulnerable who were unable to afford a lawyer in our criminal courts. I have taken on big tobacco and represented small businesses that have been undermined by large corporations.

In Congress, alongside Congressman David Trone, I've advocated for quality, affordable health care for all, emphasizing the importance of mental and behavioral health care. For too long we've ignored the immense hardship the opioid epidemic has had on our communities, particularly in Western Maryland. I've worked to advance programs that give those fighting addiction the care they need to reach recovery and as Maryland's next Attorney General, I'm ready to hold bad actors accountable, make our communities safer, and fight for a compassionate justice system that recognizes the humanity in each and every person.

I championed common sense gun safety laws, like universal background checks, a ban on bump stocks, raising the age to purchase rifles, and "red flag" laws to keep firearms away from those who might harm themselves or others. I introduced measures to fix our broken immigration system to make it more humane and just. And I've been a fierce advocate for women's rights to make their own choices about their own bodies and healthcare.

I've passed measures enhancing protections for victims of domestic violence, expanding access to the ballot for all voters, protecting the health of the Chesapeake Bay,

and ensuring equality under the law for the LGBTQIA+ community. I'm a lead sponsor on the George Floyd Justice in Policing Reform Act, landmark legislation to establish a comprehensive approach to hold police accountable and to change the culture of law enforcement by empowering our local communities. And when faced with Donald Trump's lawless presidency, I didn't back down and fought to protect our democracy.

Despite the progress that has been made, too many barriers still exist for too many Marylanders — from health care and housing; to the impacts of our rapidly changing climate and education; to policing, and the criminal justice system.

I'm running for Attorney General to dismantle these barriers, help level the playing field and push for

changes that will give every Marylander a fair shot to get ahead and ensure everyone plays by the same set of rules.

It'll take all of us, in every county of our state, to mobilize for the change and vision that Maryland Democrats share and know is possible. I look forward to working with the leaders, activists, and residents of Frederick County to get this message out.

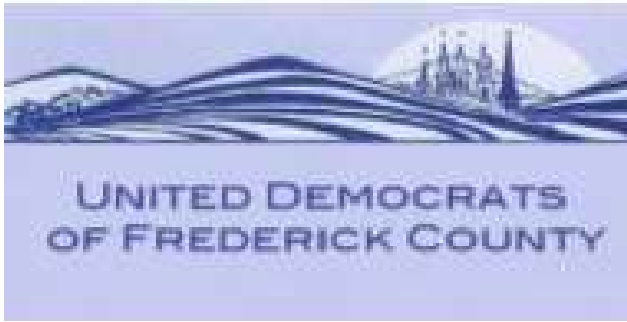
