We capped the evening by celebrating our honorees of the following awards:

Outstanding Democrat Award

Tony Soltero – Originally from Puerto Rico, Tony moved to MD in 1986 after graduating from Rice University in

Houston, TX. He worked for 35 years as a software engineer for various employers.

In 2006, Tony joined the Democratic Central Committee (DCC), serving as treasurer for 16 years before retiring from the DCC in 2022. While serving as treasurer, Tony faithfully volunteered with his fellow Central Committee members at several annual community events. He also assisted with the finance and messaging committees.

Tony has also been active in other local organizations like the Frederick Center, volunteered for the Howard Dean campaign in 2003, and served as Treasurer for Kip Koontz's successful Aldermanic campaign in 2005.

Stephen A. Legacy Award

Nina Rollins - When not working at CareFirst BCBS, Nina passionately serves the Frederick community through her work at Asbury United Methodist Church, leading many community-focused initiatives, including, but not limited to, organizing their annual coat drive, Thanksgiving Day dinner, and food and hygiene product supply drives. She also helps organize Asbury's community block party, which allows local non-profits to share information on available services to help those who need it most. She has also consistently raised awareness of Asbury UMC's and local non-profit community-led programs and services through her Facebook page.

Nina cares about the people in "our beautiful Frederick community," as she calls it, and goes above and beyond to help ensure that all have access to available services and necessities. Nina holds a Communications BA with a Public Relations concentration from Hood College and an MPS in the Psychology of Leadership from Pennsylvania State University.

Rising Star

Tomas Reyna - A 2023 graduate of Albright College, Tomas has a Bachelor of Science in Political Science and Government. He was president of their Political Science Club. After participating in his first campaign as a field director for Rep. Madeleine Dean, Tomas decided to gain as much practical experience as possible to supplement his studies. As a result, he worked with local races, building Democratic infrastructure and connections and aiding progressive groups.

After graduating, he did everything from phone banking to opposition research for a local Virginia candidate. He then took a break from elections to help local non-profits with aid efforts. Outstanding Volunteer

Richard "Kap" Kaplowitz - Kap's political interest began after watching the Kennedy-Nixon debates with his parents.

Diane Fink (At Large Biden delegate) Jessica Fitzwater (Biden alternate) (Note: since this was a virtual convention, none of these delegates got to experience attending in person a national political convention) Near the end of this year's primary ballot, just before the Board of Education candidates, you will find the candidates for delegate to the 2024 Democratic National Convention in Chicago. Three are from Frederick County: Jessica Fitzwater, Karen Lewis Young, and Tom Slater. Six will be elected from the 6th Congressional District at the May 14 primary election.

The process is somewhat confusing. Earlier in the year anyone who wanted to be a candidate for delegate to the Democratic National Convention, either uncommitted to a presidential candidate or committed to a presidential candidate, filed with the Board of Elections their candidacy application. Once the deadline for filing ended, the presidential campaigns (in Maryland that was the Biden, the Phillips, and the Williamson campaigns) were required to select those candidates that the campaign authorized to be associated with their presidential campaigns. No one filed to be a Phillips or Williamson delegate in Maryland's 6th C.D. Seventeen people in the 6th C.D. filed to be Biden delegates and six were designated by the Biden campaign to run as Biden delegates. District-level delegates are apportioned according to the votes received in the district for presidential candidates. The threshold is 15%, meaning that only presidential candidates that receive 15% or more of the vote in the district are entitled to delegates. If Phillips, Williamson, or Uncommitted to any presidential candidate receives 15% or more then they will be entitled to a delegate or delegates. Realistically, it is unlikely that Phillips or Williamson will get 15% of the vote based on primary elections in other states earlier this year. They also have no delegate candidates on the ballot. If Uncommitted to any presidential candidates receives 15% or more and becomes entitled to at least one delegate, then the person running as a delegate in the 6th congressional

district pledged to Uncommitted who receives the most votes will be selected as an uncommitted delegate to the convention and the person running as a Biden delegate in the 6th congressional delegate who receives the least number of votes among the Biden delegate candidates will not be selected as a delegate to the convention. If Uncommitted to any presidential candidate does not receive 15% or more of the vote and Biden receives more than 15% (which, based on prior presidential primary elections this year is likely to be the case, but is not a sure thing), then all six delegates in the 6th congressional district pledged to Biden will be delegates to the Democratic National Convention, So. far, in state presidential primary elections Biden has won 3,060 delegates and 27 uncommitted delegates have been selected.

Once the 63 district-level delegates are selected on May 14, the Democratic State Central Committee of Maryland will select 11 PLEOS (Pledged Party Leaders and Elected Officials), 21 At-Large Delegates, and eight alternates. Another 22 PLEOS are automatic delegates to the convention by virtue of their position such as Maryland's Governor, our two Democratic U.S. Senators, our seven Democratic members of the U.S. House of Representatives, and all members of the Democratic National Committee who reside in the State of Maryland. When the delegation to the Democratic convention is complete it will be composed of 117 delegates and eight alternates, will be equally divided between men and women and will reflect the demographic composition of Maryland's Democratic electorate as follows: 42% African American (52 delegates), 8% Hispanics (10 delegates), 6% Asian Americans and Pacific Islanders (7 delegates), 5% LGBTQ+ Americans (6 delegates), 13% People With Disabilities (14 delegates), and 30% Youth (36 delegates). Once Maryland's delegates to the convention have been selected the delegates will select three persons from Maryland to

be on each of the convention's three standing committees (Credentials, Platform, and Rules). These nine people shall also be part of Maryland's representation at the Democratic National Convention. The Chair of Maryland's delegation will be selected by the National Convention Delegates and the chair will select four persons to be Maryland's Pages to the convention.

in Maryland: (Including, but not limited to the following)

- Adequate funding to build our schools today, and the need to plan ahead to fund schools ensuring that our children are taken care of in the future!
- Keeping and attracting good staff for the schools with competitive salaries and benefits

UDFC, along with the Central Committee, WDL, South County Dems, North County Dems, and the Young Dems came together to present a Forum for the US Senate candidates running in the May Primary. On April 6, they hosted several candidates at ERUCC in downtown Frederick: Angela Alsobrooks, Brian Frydenborg, and Marcellus Crews. The candidates had time to introduce themselves, respond to 5 questions composed by the club chairs, and make their concluding remarks.

The Democratic Clubs also hosted 13 of the Board of Education Candidates at a Forum at C. Burr Artz Library in Frederick on April 18th. The candidates there also had a chance to introduce themselves, respond to 5 questions, and make closing remarks.

Several UDFC members were able to attend the Western Maryland Democratic Summitt at Rocky Gap Resort on April 11-12. It was a tremendous event with many of the primary candidates attending, as well as Gov. Wes Moore and Lt. Gov Aruna Miller. Lots of good speeches and memorable commentary were heard!

2024 Session Highlights

Residential Property Sales - Contract Disclosures - Superfund Sites

The bill requires sellers of residential properties to notify prospective buyers of the presence and location of a National Priorities Superfund Site within one mile via a signed addendum. The addendum will contain

guidance on where to obtain information about superfund sites and the impacts they can have on human health. Finally, it will notify buyers of the right of rescission within five days.

Hospitals and Urgent Care Centers -Sepsis Protocol (Lochlin's Law)

Hospitals across the state will be required to implement a CDC protocol for sepsis and require staff training on the recognition and treatment of sepsis. Sepsis is the body's immune system attacking its own organs in response to an infection. Sepsis can be caused by any infection, and infections can be caused by viruses, wounds, bacteria, and fungus. Sepsis can quickly cause organ failure, hypertension, septic shock, and death. Hospitals that implemented sepsis protocols experienced a 26% reduction in sepsis deaths.

Mental Health - Assisted Outpatient Treatment Programs (AOT)

This legislation took three years to reach fruition. This year I collaborated with the Governor's staff to improve the bill. AOT will assist a severely mentally ill individual to be voluntarily, or involuntarily under specific circumstances, admitted to an outpatient mental health treatment program. This enabling legislation can be implemented by the counties or the Maryland Department of Health (MDH). The bill also defines a process for MDH and the court to partner in ensuring treatment that provides a path to independent functioning in the community.

Maryland Community College Promise Scholarship

Although the House did not vote on the Senate bill, we successfully got our cross-file through the Senate. The bill expands eligibility for students using the Maryland Community College Promise (MCCP) Scholarship to pay for non-credit, certificate, or registered

apprenticeship programs. This effort will create greater access, preparation, and career opportunity by eliminating barriers to financial aid.

Critical Infrastructure Streamlining Act of 2024

Initially, this bill would have allowed data centers to bypass the Public Service Commission permitting process without sufficient environmental considerations. This caused significant anxiety in the environmental community. Legislative success can be measured by making a bill better. I collaborated with advocates to communicate our concerns and potential remedies. The definitive version achieves a better balance between economic and environmental goals.

Wildlife Highway Crossings

This legislation was intended to direct the State Highway Administration (SHA) to partner with the State's Department of Natural Resources to design and begin to implement road crossings for wildlife. These crossings, already found in other states, will allow animals such as deer to cross the road safely. This effort reduces animalvehicle collisions, saves lives and money, and reconnects fragmented habitats. Our bill motivated SHA to apply for federal funds made available through both the Inflation Reduction Act and the Inflation, Infrastructure, and Jobs Act.

Frederick County - Juveniles -Truancy Reduction Pilot Program

This was a local bill, but I served as the lead advocate. Ensuring the well-being of our youth is one of the most essential duties of service. Since the pandemic, truancy rates across the state have surged. During the 2021-2022 school year, 75% of Maryland schools suffered from high or extreme levels of chronic absence among students. Similarly, during the 2022-2023 term, 29.8% of Maryland's kindergarten through 12th grade students were chronically absent.

Beyond the damage that missing so much school can have on a student's education, truancy is also a risk factor for drug use, juvenile and adult criminality, suicide attempts, and employment problems. A truancy court is a six-to-nine-month program to engage families and rehabilitate youth by addressing their specific needs. In Frederick County, we have an informal, voluntary Truancy Reduction Council program that has shown positive results. Forty-seven percent of the youth referred to the program are now achieving acceptable attendance rates. The program helps stabilize families by connecting them with resources to create an environment conducive to truancy reduction. This bill will authorize Frederick's truancy program to be eligible for grant funding and expand beyond its current model.

Education - Blueprint for Maryland's Future - Alterations

I worked throughout the 2023 interim with local educators to identify challenges facing the Education Blueprint. A key provision in my legislation permits county educators to develop appropriate criteria for dual enrollment courses. The language now permits the State Board of Education and the Accountability and Implementation Board to develop qualifying criteria to ensure greater funding predictability and control at the local level.
